CHARGE OF ADVISORY BOARD

The Advisory Board shall study the potential issues related to the transfer of control of the Police Department of Baltimore City from the State to the City, including:

- implementation of the ongoing consent decree;
- management of the Police Department;
- the transfer of personnel;
- different models of local control of the Police Department;
- financial impacts of local control, including liability issues; and
- the details of a potential charter amendment to assume control of the Police Department.

CHARGE OF ADVISORY BOARD

Reporting

- On or before December 1, 2021, the Advisory Board shall submit an interim report of its initial findings and recommendations to the Baltimore City Council, the Governor, and, in accordance with § 2-1257 of the State Government Article, the General Assembly.
- On or before December 1, 2022, the Advisory Board shall submit its final report to the Baltimore City Council, the Governor, and, in accordance with § 2-1257 of the State Government Article, the General Assembly.

Ratification

- Sections 1 and 2 of this Act shall take effect January 1, 2023 or 2025, contingent on the passage of an amendment to the Charter of Baltimore City that provides for the transfer of control of the Police Department of Baltimore City to the City of Baltimore from the State of Maryland and its ratification by the voters of Baltimore City at either the 2022 or the 2024 general election.
